



Call for Nominations for CCCJ 2025 Elections

Dear CCCJ Members,

The CCCJ is delighted to announce the call for Nominations for the 2025 Election for the Board of Governors. The Canadian Chamber of Commerce in Japan (CCCJ) is governed by a 15-member Board of Governors elected by the Members of the CCCJ.

All Members in good standing are eligible and encouraged to nominate or be nominated as candidates for the Board of Governors for the **2025-2027** term. The two-year term would commence from the 2025 Annual General Meeting (AGM) of the CCCJ and end prior to the commencement of the 2027 AGM of the CCCJ (unless the Governor resigns or is removed mid-term).

The Board of Governors' mandate is to direct the business affairs of the CCCJ, determine the policies and priorities of the CCCJ and supervise the management of the CCCJ.

As representatives of the Members of the CCCJ, the Governors establish strategic objectives, approve major financial transactions, and review and approve operating budgets, to ensure that the CCCJ is managed to meet the needs of the Members and maintain financial stability.

In principle, Governors serve for a term of two (2) years and meet approximately twelve (12) times a year. In addition, Governors are expected to serve on one or more committees, to deal with specific issues or initiatives, joining committee meetings as needed, and actively engaged in various Chamber activities as much as possible.

As of the 2018 elections, the 3-term limit for governors was removed. However, governors hoping to run for another term will be requested to include some mention of their contribution during their past term in their introduction. Attendance records at board meetings will also be made public.

Prospective Governors come from all walks of life and bring varied experience to the CCCJ Board of Governors. All Governors share an interest in business between Canada and Japan and a desire to help the CCCJ reach its objectives.
